**Democratic Period/Public Time** – Parishioners spoke of their concerns regarding the speed of traffic through Upper Sapey. Pedestrians walking into the village from Sapey Golf Club and the Baiting House are, it is felt, putting their lives at risk.

## 9. Ward Councillor's Report

9.1.1 NS advised that, as the signs in front of Saltmarshe Caravan Park are smaller & comply with current regulations, HCC accepted an out of court settlement.

The tree officer will be soon be making a visit to the caravan park to check on the current state of the protected trees.

NS will be presented the new budget to full council next week. A recommendation of an increase of 4.9% is to be made. This included increased monies for adult care.

NS hopes that an additional £5million will be made available for countryside road maintenance. This money may come from the "Amey" fund.

Sapey crossroads has had new white lines. Sapey Common and Upper Sapey (Golf Club/Baiting House) are scheduled to be done.

NS recommends evidence is gathered and says that a petition could be helpful in respect of the speed problem at Upper Sapey.
