

Brockhampton School has received a "good" Ofsted report.
Porthouse Road in Bromyard has had 28 potholes filled.
HCC "won" £5 million for tarmacking, this money must be used within a set time.
The court case of HCC verses Saltmarshe Caravan Park in respect of the signage issue has been postponed until 26/10/17.
The TPO's for the trees at Saltmarshe Caravan Park have been signed.
